REQUIREMENTS NECESSARY FOR ANY CREDIT REQUEST

- All information on this form is required to submit a warranty claim.
- Claims must be submitted within 30 days of failure date to be considered.
- Claims will not be processed without the water heater owner's pertinent information.
- Requests for credit will be validated by the water heater's serial number located on the data plate of the unit.
- A "proof of purchase" must be supplied when the serial number of the water heater indicates it is out of warranty.
 - 04: The first two digits of the serial number represent the year of manufacturing.
 - 01: The second two digits represent the week of manufacturing.
- To obtain credit for a failed water heater, the failed unit must be replaced by an American Water Heater.
- Commercial heaters require a leak verification form be filled out and returned with this claim form.
- Labor reimbursement will be processed for residential units installed/operational for 1 year or less.
 - \$70.00** Maximum labor credit for part(s) replacement.
 - \$135.00** Maximum labor credit for complete residential water heater replacement.
- Labor reimbursement will be processed for commercial units installed/operational for 1 year or less.
 - \$95.00** Maximum labor credit for part(s) replacement.
 - \$150.00** Maximum labor credit for complete commercial water heater replacement.
- The data plate from a failed water heater must be affixed to the reverse side of this form.
- A request for labor reimbursement must be submitted to AWHC on a professional contractor's invoice which must include pertinent customer information, model/serial number, reason for service and explanation of service performed or parts replaced.
- All warranty claims will be audited. Fraudulent claims will be denied.

- WATER TEMPERATURE ADJUSTMENTS
